

Ordinance No. 2021-01
An Ordinance Amending Section III. Routes, and Section IV. Conditions
of the Town of Dakota's
All-Terrain Vehicle (ATV) and Utility Terrain Vehicle (UTV) Ordinance

WHEREAS, the Town of Dakota previously adopted Ordinance No. 2011-9 An Ordinance To Approve and Regulate All-Terrain Vehicle (ATV) and Utility Terrain Vehicle (UTV) Travel on Roads in the Town of Dakota, Waushara County, Wisconsin, and Prescribing Penalties for Violation Thereof, which was later amended by Ordinance Nos. 2013-2 and 2015-2; and

WHEREAS, it has been requested that 4.2 miles of Town of Dakota roads be added to the town's existing routes; and

WHEREAS, the Waushara County Highway Commissioner and Sheriff have reviewed the request and have no concerns;

THEREFORE, the Town of Dakota Board does ordain that the Town of Dakota's ATV/UTV ordinance be amended as follows (changes/additions shown in bold/underline):

SECTION III. Routes

Roads to be open for ATV/UTV routes are as follows:

- 14th Avenue from Marquette/Waushara county line north to County Road JJ;
- 14th Avenue from County Road JJ north to Czech Court;
- Czech Court west to County Road Y, and Czech Court east through sections 32, 33 and 34 **to that road's end at 16th Drive;**
- 16th Drive from Czech Court south to the county line;
- Dakota Avenue, from intersection with 16th Drive east one-tenth of a mile to Crystal Lake town line;**
- Cypress Road from County Road Y west to Town of Richford town line;
- Czech Road from 14th Avenue west to 13th Drive;
- 13th Drive south to County Road JJ;
- 17th Drive from Wautoma city limits south to Cottonville Lane;**
- Cottonville Lane west until it becomes Cottonville Drive;**
- Cottonville Drive from intersection with State Road 22 west to County Road Y**

SECTION IV. Conditions

As a condition for the use of this route, the following conditions shall apply to all operators and passengers:

- A. All ATV/UTV operators shall observe posted roadway speed limits.
- B. All ATV/UTV operators shall ride single file on extreme right side of roadways.
- C. All ATV/UTV operators shall only ride on paved surface of roadways.
- D. All ATV/UTV operators shall slow the vehicle to 10 mph or less when operating within 150 feet of a dwelling.
- E. Routes must be signed in accordance with NR 64.12, and NR. 64.12(7)c; **the responsibility for which will fall on the local ATV/UTV association/group.**
- F. Routes will be open for public ATV/UTV usage daily during the following time periods: 5:00 a.m. through 12:00 a.m. (midnight).

BE IT FURTHER ORDAINED that access to 17th Drive, Cottonville Lane and Cottonville Drive are contingent upon the Waushara County Board of Supervisors allowing ATV/UTV usage on County Road Y within the Town of Dakota; and

BE IT FURTHER ORDAINED that roads must be marked before they are open to ATVs/UTVs; and

BE IT FURTHER ORDAINED that all other sections and provisions of the Town of Dakota's ATV and UTV ordinance remain unchanged and in effect; and

BE IT FURTHER ORDAINED that this ordinance will be enacted the day after posting per s. 60.80, Wis. Stats.




