

**Resolution No. 2022-03**  
**Resolution to Accept Ownership of Maple Grove Cemetery**

WHEREAS, the Maple Grove Cemetery Association, formerly known as the Raymond Cemetery Association, has overseen operations of the Maple Grove Cemetery since April 1881; and

WHEREAS, the sole members of the Maple Grove Cemetery Association are Mark and Holly Dahlke; and

WHEREAS, the members of the Maple Grove Cemetery Association are no longer able to oversee cemetery operations and have voted to convey ownership of all cemetery property, including but not necessarily limited to, all real estate and trust fund proceeds, to the Town of Dakota; and

WHEREAS, Wis. Stats. sec. 157.064(5) allows a cemetery association the power to transfer all cemetery property to the city, village or town where said cemetery is located upon the acceptance of the transfer by resolution of the governing body of the city, village or town; and

WHEREAS, at a September 12, 2022, meeting, the Town of Dakota Board of Supervisors voted to accept ownership of the Maple Grove Cemetery, which is located in the Town of Dakota and is more particularly described as follows:

Certified Survey Map No. 6864, as recorded in the office of the Register of Deeds in and for Waushara County, Wisconsin, on October 24, 2022, as Document No. 540870; and being a part of the SE ¼ of NE ¼ in Section 24, Township 18 North, Range 10 East, Town of Dakota, Waushara County, Wisconsin.

NOW, THEREFORE, BE IT RESOLVED that the Town of Dakota Board of Supervisors accepts ownership of the Maple Grove Cemetery, including all real property, trust proceeds, and other property as currently owned by the Maple Grove Cemetery Association, and shall cause to be recorded an Order conveying ownership of the real property as described herein to the Town of Dakota after the proper publication/posting of this resolution.

BE IT FURTHER RESOLVED that the town clerk shall property publish/post this resolution as required under Wis. Stats. sec. 60.80.
